

In Appreciation

My inaugural term as President of Mid-Atlantic Great Dane Rescue League, Inc. was one of both challenges and successes.

The challenges have been many. We accepted numerous Danes from neglectful situations and irresponsible breeders, and supported legal actions against the offenders. We helped orphans in need of major veterinary care ranging from heartworm treatment, to ligament repair, to limb amputation. We faced challenges based upon the sheer size of our organization, ranging from balancing high numbers of Danes in some chapters by moving them to chapters with open foster homes, to attrition in key areas of MAGDRL leadership; to the ongoing challenges of financial management.

Yet in 2006, our challenges were greatly overshadowed by our successes. Thanks in great part to our education and counseling efforts, during 2006, MAGDRL chapters accepted fewer Great Danes into rescue than in 2005. This year, our Chapter Coordinators did an outstanding job of containing costs, thus reducing expenses over prior years and avoiding a 2006 intake moratorium.

At the heart of MAGDRL's success in 2006 are our volunteers who arose in response to our challenges. Volunteers continued to host recurring rescue events, while developing new and innovative fundraisers and publicity campaigns. This year we welcomed 15% more MAGDRL volunteers than in 2005. The BOD values their contributions and will continue to keep communications channels open through the Chapter liaisons and the web contact page.

On a final note, sincerest appreciation goes to our patrons, donors, sponsors, and supporters without whom MAGDRL could not survive. Remember

that no matter how each of you helps, you enable MAGDRL to make a difference for the Danes in our care.

At the top of my list of goals for 2007 is to invite you to join us in building upon the successes of the past — by helping one Dane at a time!



To raise awareness of canine health and ownership challenges, I researched and shared serious topics including Coping with the Loss of Your Pet, Health Causes for Aggression, and Finding a Lost Dog. # **Sobering Statistics**

HSUS reported in 2006 that U.S. shelters handled 6-8 million animals. Roughly 64% of the total number of animals were euthanized - approximately 3-4 million animals in the 1,000 shelters surveyed. Only 15% of lost dogs that enter animal shelters are reunited with their owners. Only 25% of dogs in animal shelters are adopted.

A contributing factor to the staggering number of animals that face euthanasia every day is owners who fail to spay and neuter their pets. Please spay and neuter, and adopt your next animal companion from rescue.

# **NoVA**

The Northern Virginia chapter started this year out with gusto and just kept on going, The growth of our fundraising opportunities were phenomenal with the help of our volunteers, and we were able to bring in over \$2,000 with our first ever Yard Sale. We also started the organization-wide Penny War, started Zazzle clothing, sold Gold Canyon Candles, continued eBay, had our first very successful Art Auction, (which we hope to do again in the future) and added to our Meet & Greet locations. Our total for fundraising for 2006 was \$23,521.56 and we spent \$14,880.61 on health care.

We could never have raised this much without being truly blessed to have such outstanding volunteers here in N. VA, where we are more like family than just volunteers. We do our best to bring our volunteers together outside of the rescue as well. This type of teamwork has helped us recruit many new volunteers and fosters to help the Danes.

We were able to coordinate with other chapters and transported several Danes to our area to help alleviate overflow of kenneling. We have been very fortunate that our give-up calls are few and that we don't seem to have many back-yard breeders in our areas. We placed 24 Great Danes in our chapter and only had

4 bounce back into the system, all of which were adopted again.

We have a lot of new fundraising things planned for 2007 and are looking forward to working with all of our outstanding volunteers and fosters. Our chapter continues to grow because of the dedication we have for the Danes. We want to thank all our volunteers for supporting us and giving their time to the rescue.



# PA/DE

The Pennsylvania and Delaware Chapter had another record year in 2006. We were blessed to have many profitable events this year which allowed us to bring in more income than we spent. Our annual Dog Fest reported record breaking profits this year, clearing more than \$8000.00 from this fabulous event. We were also pleased to be able to bring back the Education Brunch which was well attended, not only by our own volunteers but also from other chapters and rescues.

Our phone lines were as busy as ever with a total of 350 calls this year. We process 111 adoption applications and had 46 adoptions. We took 139 Turn In calls, of which 42 were taken in the program and 11 were transferred to other chapters. We were able to help 23 families keep their dogs and 4 were returned to their breeders. There were 37 dogs either placed by their owners or the shelters before we were able to bring them in and sadly there were 22 who we turned down for temperament / bite histories.

# **Volunteer Chair**

Our volunteers are what this rescue is all about and I'm happy to represent them on the board! Without the wonderful volunteers and fosters, we would not be able to help as many Danes as we do! All the chapters have done a great job bringing in new volunteers to increase our fundraising, M&G's, events and fostering .

As we continue to grow, teamwork becomes more and more important to our success. In 2006 we had 596 volunteers, compared to last year's total of 454, which is an increase of 142. Keep up the great work everyone!

### MD/DC

As 2006 came to an end, we were deep in planning for a volunteer training and appreciation event for all of our MD/DC area volunteers and foster homes. We want to make sure our volunteers know we couldn't do it without them!

New York's small team of volunteers held up pretty well for a very busy year. Overall we took almost 600 calls and e-mails inquiries for adoption. We were called to give up 95 Danes, of which we took in 27 with a 9 Dane carry over from the previous year. Out of those, we placed 21, moved 2 to out of state to foster homes and had to help 2 Danes across the Rainbow Bridge due to age related illnesses.

Our funds were tight and unfortunately we ended the year in the red by approximately \$5600. We attended a few events, but New York is still lacking the volunteer force that some other chapters are lucky to have. Large events are hard to pull off as our members are just too far spread across the state.

We did make some great contacts and were able to design a brand new website. which was unveiled the end of 2006. A huge "Thank You" goes out to Patti and Mark Ursel of Firsthand Software, who donated the design and hosting fees of the new Site. Be sure to visit us on the web. It is a work in progress, but looks much more professional than the old site.

Our focus for the next year is to increase volunteer and foster home base and to eventually organize a big fundraiser.

# Southern VA

Well here we are, another year older and still very hard at work. Southern Virginia has been very lucky in gaining more volunteers, more foster homes, and improving relationships with many of the shelters, some as far southwest as Roanoke and Lynchburg to as far north as Bedford, Chesterfield & Fredericksburg, to right here in Virginia Beach and Norfolk.

We answered over two hundred calls covering owner surrenders to health and training questions. The Southern Virginia Chapter took in 62 Danes in 2006, placed 57 of them and had five still waiting for their forever homes at the end of the year. The longest had been with us since March and he has since found his forever family.

Our fund raising efforts remain about the same, we have a difficult time doing weekly Meet & Greet events because we are so spread out and cover so many miles.
